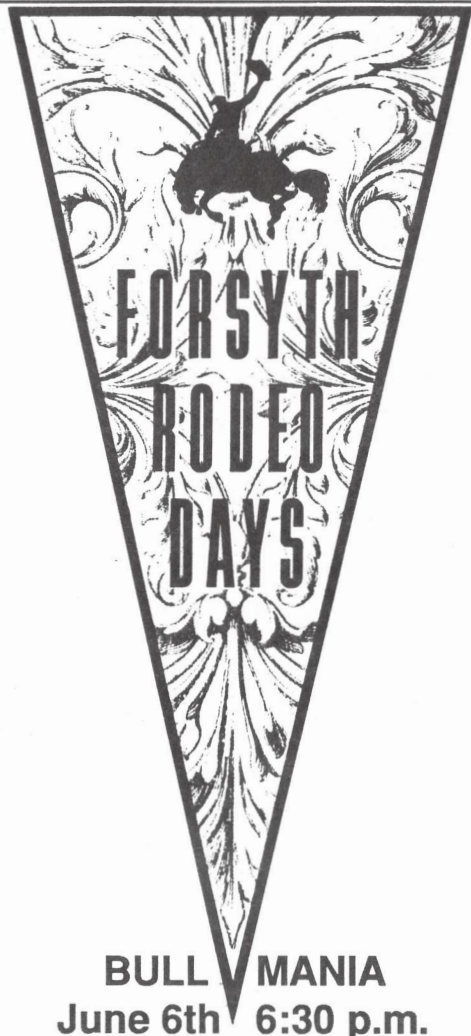

Rodeo Contractor dies

NRA rodeo contractor John A. Carpenter, 60, Kalispell, died April 17 in Kalispell of natural causes.

Carpenter was active in rodeo and organized many throughout Montana. He also owned Kalispell Livestock Auction.

He was born Nov. 9, 1931, in Walkerville, Mont., a son of Leighton and Teresa Carpenter. He attended school in Walkerville and served in the Marines.

He married Jill Powell in Boulder in 1957 and they made their home in Butte until they moved to Hot Springs in 1968. They bought Kalispell Livestock Auction in 1969 and moved permanently to that city in 1970.

John is survived by his wife; daughter, Jeanne; sons, Richard, John and Kenny, all of Kalispell; sisters, Tina Else, Sheridan, and Cora Dennehy, Phyllis Petritz, Birdie Mullaney and Marcella Dalaserra, all of Butte; brothers Carl of Butte, Bob of California, and Myles and Dale, both of Melrose, and three grandchildren.

Services were Weatherford Funeral Home in Kalispell with the Rev. Robert Noonan officiating. Memorials are suggested to the Shriner Hospital for Crippled Children, Box 2472, Spokane, Wash. 99210-2472.

NRA rulings and procedures on Trade-outs/ Turnouts

All NRA rodeos are tradeout rodeos unless advertised as "NO TRADEOUTS."

Trades: A contestant may trade positions/performances of competition with another contestant at anytime after entries close, provided it is before the draw for that event.

If a trade is completed before callbacks close, trades are handled through central entry and may continue to be handled up until 10 a.m. the day following callbacks.

After 10 a.m. the day after callbacks, all trades are handled through the NRA office.

Both parties involved in the trade must call the NRA office and confirm the trade.

Trades can be made at the rodeo upon consent of both parties involved, before the draw in that event. Both judges and rodeo secretary must be notified of trade by both parties.

Note: A new rule passed at April 1992 board meeting states timed-event draw must be made in presence of the rodeo secretary and can be made a minimum of *two hours* before the performance. We bring this to your attention so contestants plan to make trades earlier.

Turnouts: As stated in the rule book, if a

contestant turns out at a rodeo, the fine will be equal to the entry fees. The NRA has rules which can soften the blow of an expensive turnout.

1. **Notified turnout:** If you know before 3 p.m. the last working day before the first performance of a rodeo that you will not be competing at that rodeo, call the NRA office. You will be responsible for your entry fees plus a \$20 fine. The fine is \$20 (plus all entry fees) no matter how many events you are entered in. You must have your entry fees included in the payoff for that rodeo in which you will not be competing, so alternative ways to get your fees to the rodeo need to be considered.

2. If it is too late to notify, you can find someone who will pay your fees at the rodeo for you and notify the secretary/judge/contractor that you will not be there, your fine is half your entry fee (plus your entry fee).

Contractors/judges/secretaries/spectators/announcer and fellow contestants appreciate knowing if you will not be there, thus an animal will not be drawn and this will eliminate unnecessary turnouts.

NON-CONTESTING CONTRACT PERSONNEL - \$25

MEMBERSHIP: Entitles purchaser to work all sanctioned rodeos without restrictions, to share all advantages of a member in good standing including such items as a guarantee of your entry fee; check writing privileges after the first year initiation period; and a subscription to the newsletter.

NEWSLETTER: The official publication of the NRA featuring current data regarding the Association and NRA sanctioned rodeos, information of all association business, as well as interesting news articles and exciting photos.

PERMITS: Entitles purchaser to work all sanctioned rodeos accepting permits as listed in the newsletter until \$500 is won. After \$500 money limit is won by permit holder, a card must be purchased. The price of card to be the dollar difference between the cost of a permit and the cost of the card. Permit holder's points will be credited to the yearend standings, however, the contestant must be a card holder to compete at the NRA Finals. The \$500 money limit will be accumulated from year to year, allowing the contestant to purchase a permit each year until the \$500 is won. A card holder the previous year cannot purchase a permit the following year.

Back side of application must be completed to guarantee processing of membership application.

RELEASE AND AGREEMENT NOT TO SUE

In consideration of being allowed to participate in Northern Rodeo Association sanctioned events and membership in the Association, I and my heirs, successors, personal representatives and next of kin, hereby RELEASE, WAIVE, DISCHARGE and agree to HOLD HARMLESS AND INDEMNIFY the Northern Rodeo Association, the rodeo committees, stock contractors, sponsors, arena operations or owners, their agents, representatives (collectively referred to as the NRA) from all liability to me and my personal representatives, heirs, successors, and next of kin from and all claims and liability for all loss of damage, and any claim of damages therefore on account of any injury to my person including death or damage to my property while I am utilizing NRA facilities or participating in NRA events.

I, hereby represent to the NRA that I understand that THERE ARE CERTAIN RISKS OF SERIOUS INJURY AND DEATH inherent in participating in rodeo events and any related activities. I realize conditions of the rodeo arena change from time to time and may become more hazardous, that rodeo animals are dangerous and unpredictable and there is INHERENT DANGER in rodeo which I appreciate and voluntarily assume because I choose to participate in such events. I make this choice even though I have observed or participated in events of this kind in the past and know conditions, facilities, rodeo animals, and other rodeo contestants and participants pose a danger to me. I recognize and expressly agree to assume the entire risk of any and all accidents or personal injury including serious paralysis or death which I might suffer during my participation in said events.

I further COVENANT AND AGREE NOT TO SUE THE NRA for any injury, damages or death which occur as a result of my participation in said events and any claim or damage therefore. I understand that this document maybe treated as a complete defense to any legal action I might bring against the NRA for any injuries or other damages I might suffer.

I understand and agree this RELEASE AND AGREEMENT NOT TO SUE extends to any and all claims I may have, specially including but not limited to, claims arising out of participation in said events, claims with respect to the design, manufacture, repair, or maintenance of the facilities or equipment which I will be using, or with respect to the conditions, qualification, instructions, rules or procedures under which my use of said facilities or equipment are conducted or from any other cause.

I UNDERSTAND AND AGREE THIS RELEASE AND AGREEMENT NOT TO SUE extends to ACCIDENT, INJURY, OR DEATH OCCURRING DURING THE TERM OF MY MEMBERSHIP IN THE NRA. Any subsequent Releases and agreement I might sign in the future shall amplify, but shall in no way limit, the provisions of this document.

I further state and certify that I have carefully read the foregoing Release, know the contents thereof and sign this Release and Agreement Not to Sue as a free and voluntary act. I am not relying on any statements of representations of any party released hereby. I UNDERSTAND THIS IS A RELEASE OF ALL CLAIMS.

1. Entries will be open from 10 a.m. to 6:30 p.m. every Monday. Call backs will be on Tuesdays from 12 Noon to 6:30 p.m. UNLESS OTHERWISE ADVERTISED.

2. Give the following information when entering a rodeo.

- (a) Name of Rodeo
- (b) Your N.R.A. Membership Card Number
- (c) Your Name
- (d) The event or events you want to enter
- (e) Preferences you have on when you want to be up.
- (f) Name of buddy or buddies — two per event, six total
- (g) If multi-rodeo weekend, give information for each rodeo you wish to enter.

3. Every conversation, both entries and call backs, are recorded on tape, and each cowboy is given the verification number for that conversation. YOU MUST HAVE THIS VERIFICATION NUMBER IF THERE ARE ANY QUESTIONS REGARDING YOUR ENTRY OR CALL BACK.

10. Call Back on Tuesday to find out when you are up.

ANY CONTESTANT WHO DRAWS OUT OF A RODEO AFTER RECEIVING THEIR FIRST PREFERENCE OF PERFORMANCES AT A GIVEN RODEO OR RODEOS WILL BE FINED \$20 PER INFRACTION.

Page 34, #20 A, IN ALL TIMED EVENTS WHERE A NECKROPE IS USED, STRING SHALL BE THE ONLY MATERIAL USED TO TIE NECKROPE

Page 63, #5 and entire rule include on page 18, #4 A: JUNIOR EVENTS SIX MONEY PAYOFF CHANGED TO STANDARD NRA SIX-MONEY PAYOFF

Page 30, #4: DELETE "IF ONLY ONE OF TWO ANIMALS REMAIN TO BE DRAWN FOR THE NEXT DAY'S PERFORMANCE, THOSE CATTLE WILL NOT NECESSARILY BE DRAWN FIRST AND SECOND, BUT MUST BE RANDOMLY DRAWN IN THE FIRST SECTION." Thus all cattle will be run consecutively.

Page 12, #8 C: Wording to read: "RODEO OFFICIALS PAID PERFORMANCE."

Page 46, new section 10 A: ROOKIE BAREBACK RIDING: GUIDELINES INCLUDE: 1. CONTESTANT MUST BE A MEMBER OF THE NORTHERN RODEO ASSOCIATION, PERMIT HOLDERS CONSIDERED MEMBERS. 2. CONTESTANT MUST NOT HAVE A LIFETIME WINNINGS OF OVER \$500 IN THE BAREBACK RIDING EVENT, EXCLUDING HIGH SCHOOL, JUNIOR RODEO AND COLLEGE RODEO. #. New NRA Judge's Program

- 1.) A judging committee will be appointed by the NRA Board of Directors. The judging committee will assign judges to each rodeo at least one month prior to the rodeo (unless previous arrangements have been made by the committee or contractor for the 1992 season only).
- 2.) Three levels of judges (Determined as follows)
 - a. Level I - Top six judges as determined by balloting used for the 1992 NRA finals. Judge must attend a conference before they qualify for Level I status and compensations. Will judge top five NRA rodeos based on previous year's total purse at the rodeo.
 - b. Level II - Must have several years judging experience, must have attended a judging seminar within the past two years and must have attended a judging conference within the last year.
 - c. Level III - Must have a minimal amount of judging experience and must have attended both a judging seminar and a judging conference within the past year.
- 3.) Judging Seminars that qualify are seminars conducted by the NRA or the PRCA. The purpose is to concentrate on the specific rules in the rulebook.
Judging conferences that qualify are conferences conducted by the NRA. The purpose is to concentrate on specific judgement calls that are not addressed in rulebook and to assure a consistency in these calls.
- 4.) Judges will be evaluated periodically during the summer.
- 5.) Additional details concerning the judging program will be addressed by the judging committee, as necessary.

** Special Note **

A judge that does not meet the qualifications as defined above and judges an NRA-approved rodeo will only be paid as required by NRA rulebook.

6.) Program costs

Level I Judge will receive, in addition to the amount specified by the NRA rulebook, \$5 per performance from the NRA at all rodeos they judge, the amount specified in the NRA rulebook is still the responsibility of the individual rodeo committee or contractor, and - will receive a \$50 bonus per rodeo if they judge one of the NRA's top five rodeos.

Level II & III Judges will receive, in addition to the amount specified by the NRA rulebook, \$5 per performance from the NRA at all rodeos they judge, the amount specified in the NRA rulebook is still the responsibility of the individual rodeo committee or contractor.

Administrative costs - the NRA will provide assistance to individuals who put on seminars or conferences as necessary.

From our Mailbag

To the officers and membership of the Northern Rodeo Association:

The purpose of this letter is to inform you of a bill being sponsored in Congress by Rep. Peter Kostmayer, (D-Penn.). The bill is known as HR3252 and "specifically names rodeo as cruel, inhumane and unnecessary."

At last report, the bill was lodged in the Departmental Operations Subcommittee of the House Ag Committee. To receive the specific details and current status of the bill, you may contact one of the congressmen or senators listed in this letter.

I regret that I do not know the name of the specific organizations that lobbied Rep. Kostmayer to introduce this bill. I do, however, have some ideas of the type of information that can be passed on to our senators and congressmen in opposition to the bill:

- 1) Write a letter to both senators and congressmen of your state.
- 2) In the first paragraph of your letter, it is imperative that you make it clear that you oppose this bill. Use the words "opposed to" or "opposed" to make your position clear.

- 3) Cite rules from the rulebook of your rodeo association (s) that are designed to protect the welfare of the stock and rules that levy fines against contestants who abuse stock. Also note rules that take competition privileges away from repeat offenders.

- 4) Stock contractors can send pictures of their stock during the rodeo season and during the off season as evidence that these animals are well taken care of and that the use of the stock for the purpose of rodeo is not detrimental to the welfare of the stock.

- 5) Members can attest to the condition of the stock as well.

- 6) The condition of the competitors personally-owned horses should be attested to also. Send pictures of healthy horses to prove that the health of our animals is second to none.

- 7) Secretaries of rodeo associations can cite statistics of the amount of members who are fined for abuse. Use a ratio or percentage as a

basis for these facts. Use this strategy only if it is to the benefit of our cause. The last thing we need to do is send information that they can blow our of proportion and use against us.

- 8) Note the economic benefits to the small communities that host rodeos. These small communities would not receive the economic benefits that contestants and local residents contribute if they were not able to host these rodeos.

- 9) It is more effective for each voting member of the household to send his or her own letter. For example, if a husband and wife send one letter to a congressman that is signed by both, it is counted as one opinion, not two. You can send the same letter, but send one for each person.

- 10) Keep in mind there is power in numbers. Our best ammunition will be the amount of responses we get to our representatives.
