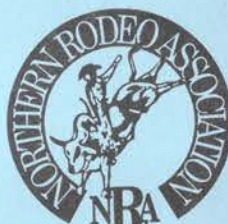

CHATting WITH CHUCK ABOUT SPORTS MEDICINE...

Soft Tissue Bruises

Most soft tissue bruises (contusions) are caused by direct blows to the tissues, often muscle tissue. Bruises are the result of bleeding into the tissues, as well as possible physical damage of the tissue. In rodeo, bruises often result from rather extreme forces such as being kicked, stepped on, or thrown into something. Thus bruises seen in rodeo contestants can range in severity from the mild to moderate contusions common to other sports to very severe contusions not often experienced in most other sports.

When you get hurt, it is often difficult to know the severity of your injury; therefore, how it needs to be dealt with. It would be easiest for me to advise you to see a Doctor with all your problems, but you are not going to do that and it would not be necessary either. The following comments are intended to help you manage your injury, if you are unfortunate enough to get hurt.

Common Sense - Common sense is possessed by all people. Your use of it is affected by how your "image" might be directing you, how you perceive others might want you to act, denial, fear of the truth, and experiences among other things. If you took a "direct hit" involving a lot of force, the probability of your

being hurt significantly is quite high, but not absolutely so. If you did not get hit very hard or the force of the blow was dissipated, the probability of your being hurt significantly is quite low, but not absolutely so. If, in those first moments following injury, you felt quite weak, lightheaded, nauseated, and were pale in addition to experiencing real pain you might have a real problem.

If anything-pain, swelling, sensation, weakness- seems dramatically wrong, seek advice from a competent practitioner ASAP. If you decide to handle the problem on your own, the expectation should be that your body will make a move to heal the injury with noticeable results within 24-48 hours. This improvement should continue, perhaps with some setbacks due to aggravation, until healing is complete. If you have doubts about the severity and/or reasonable caring people are suggesting that you get a problem evaluated, it is probably best to do so.

The immediate care of bruises should include the use of ice and pressure. Many practitioners believe that pressure (compression) is the most important of the two.

Compression - The traditional method of applying pressure has been the use of an elastic wrap ("Ace"), however elastic sleeves, binders, belts, etc., have gained popularity. An elastic wrap should be placed over the area, providing ample tension to give a feeling of snugness. It is helpful to wrap the bandage once around the affected area, then place the ice bag on the area and continue with the wrap so that the ice bag is held in place by the elastic wrap. After the ice treatment is completed, remove the wrap, reroll it, and then apply it again over the

affected area to provide compression. Always start away from the heart (nearest your fingers or toes) and apply the bandage moving toward the heart. The wrap should be snug, but not so tight as to turn the fingers or toes numb and blue! Numbness, weakness, aching, burning, tingling or abnormal color distal to the wrap is a bad sign - loosen it!

Ice - Cold should be applied to the injured area until it becomes numb. Depending on the size of the injured part, 7 - 20 minutes will usually suffice. Remember - only until it becomes or comfortable - don't set a clock. Repeat every 4 - 6 hours for several days if necessary. Icing should be utilized after exercising especially if the injury has been aggravated until it has healed.

Elevation - The injured part should be placed (or elevated) above the level of the heart as much as possible. For an injury to the lower extremity (leg), placing a suitcase under the foot of the mattress will keep the legs higher than the heart when sleeping.

In order to prevent contusions to the musculature, whenever possible wear protective padding. This takes on added importance when attempting to prevent aggravation to an injury while it is healing.

Rest - A period of rest will help minimize many injuries. If tissue damage has occurred, the injury site must stabilize itself, such that healing can occur expediently. This is not an absolute concept. Usually, use within the limits of discomfort -not pain- will allow healing to be initiated. If you are unsure, 12 - 48 hours of complete rest is the safest.

Support - Most injured tissue will feel

better if, as you start to reuse it after an injury, it is supported. Again elastic wraps etc., work fine, but, the neoprene supports provide the added benefit of warmth.

RODEO COWBOY ANNOUNCER

His license plate reads, "Rodeo MC" and "He calls it like he sees it!" Born and raised in Whitefish, MT, the 42 year old cowboy rodeo announcer, Joe Warner, first started his career in 1986. He worked every Saturday and Sunday- May through October until 1989. Without Mike and BeeGee Cole, Warner says he wouldn't have gotten a chance to start announcing. "They are real special people in my book," says Warner.

From there his career took off, a bit too slow at times to suit Warner but he says patience was never one of his best qualities. Each year more rodeos are being added to his list. Announcing the 1993 Chinook Rodeo Association Finals in Taber, Alberta, was definitely an added plus to his career. During the 1994 Northern Rodeo Association season, Warner announced the 1994 NRA "Rodeo of the Year" the Great Northern Fair in Havre; Upper Yellowstone Roundup, Gardiner; Big Timber Promotion Association Rodeo in Big Timber; and the Jefferson County Fair in Boulder.

No matter what size of the rodeo or the crowd, he announces each rodeo in his professional style to that one special person sitting in the stands that doesn't know a thing about the sport of rodeo. "I love rodeo, and I have fun when I announce. It's contagious, it makes the crowd and the cowboys have fun," Warner says. Rodeo is such a family oriented sport, produced by families, participated in by families and

and spectated by families, says Warner. "When the colors are brought into the arena, the National Anthem is played, and introductions are made, it's a real high," he commented. "But then, when they open the gate on the first bareback rider, (one of my favorite events) the adrenaline really gets pumping. We're ready to rodeo!"

"When you ask a High School Cowboy who's just ridden his first Bareback horse what his goals are, he'll say the NFR (National Finals Rodeo). It's the dream of every cowboy going down the road," says Warner, who also holds that ultimate goal.

It definitely takes more than just a truck with "Rodeo MC" on the license plates to be an announcer. He pulls a sound trailer with a state of the art, 600 Watt Sound system to each rodeo. He feels his sound system has really paid off because of its excellent quality sound.

Not only is Warner busy announcing rodeos throughout the year, he also has a radio program "Behind The Chutes With Joe Warner" which airs 5 days a week on a local radio station. "It was just gonna be a short run program but the sponsors had such a good response that they kept going with it."

Joe loves being involved in Community activities. Warner is an auctioneer and he sells auctions for 4-H, Log Jam, Winter Classic, Animal Circuit, Rocky Mountain Elk Foundation and he also coaches baseball. "Anything to do with kids or any family oriented event, I'll be there with mic in hand," Warner says.

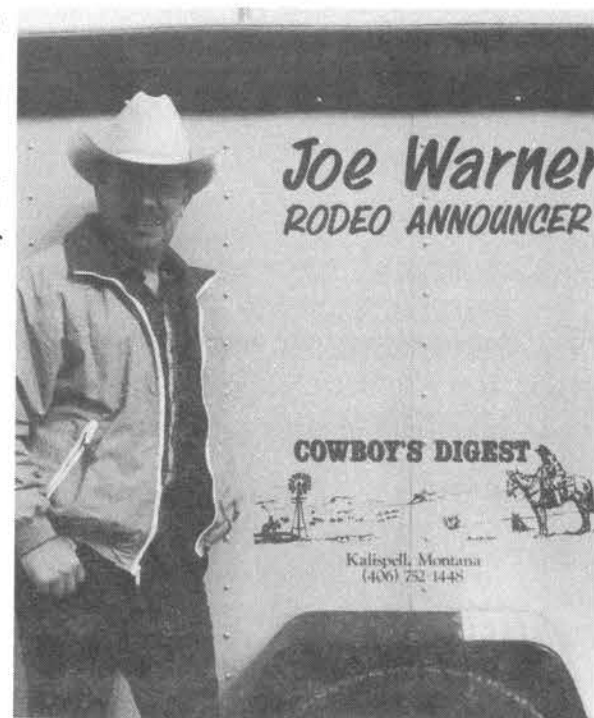
Joe started out in high school rodeo, participating in all the events except saddle bronc. After high school he continued to rope

calves and team rope. "I'd like to say I was really good!" as he laughed, "But there are too many cowboys who rodeoed with me back then who know different. The last time I roped calves was at the Hot Springs Rodeo, I had a perfect run for me, everything went great, my horse worked good, I flanked and tied my calf extremely well and my time was a 14.5, I was pumped, cause it really felt good. But, then two high school kids came out and tied their calves in 10.0, that's when I burned my grass calf rope and went on to team roping. I won Patterson's Annual Team Roping a few years back and won a buckle, I'm still wearing it," Joe said.

"I would never be able to do this if they (his family) all weren't so supportive and behind me 100 percent," commented Warner. His wife Judy stays home with daughter Sunny Rae, 10, to hold the ranch together while he's gone on the weekends. The oldest son, Dan, 18, has a full time job and Luke, 15, travels with dad sometimes on the weekends.

The Warner's raise quality commercial feeder calves on their ranch. His father and mother, Russell and Jeanne Warner, live on the bordering ranch. "It makes it really nice, because we can help each other out when needed," Joe says.

"To sum things up," Warner says, "No matter what happens, if I were to never announce another rodeo it wouldn't matter, because I dearly love the sport of rodeo! It's so gratifying to form those special bonds and friendships with the families that rodeo."

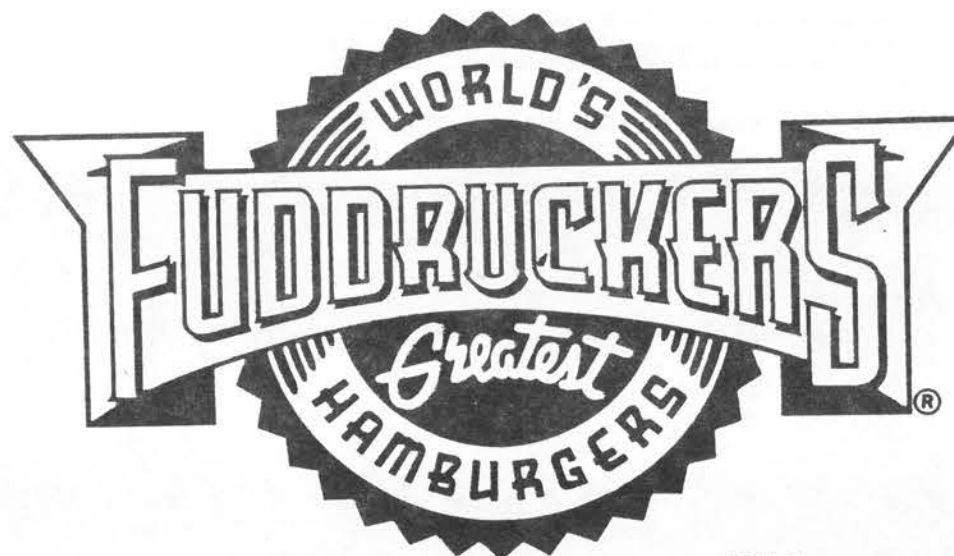

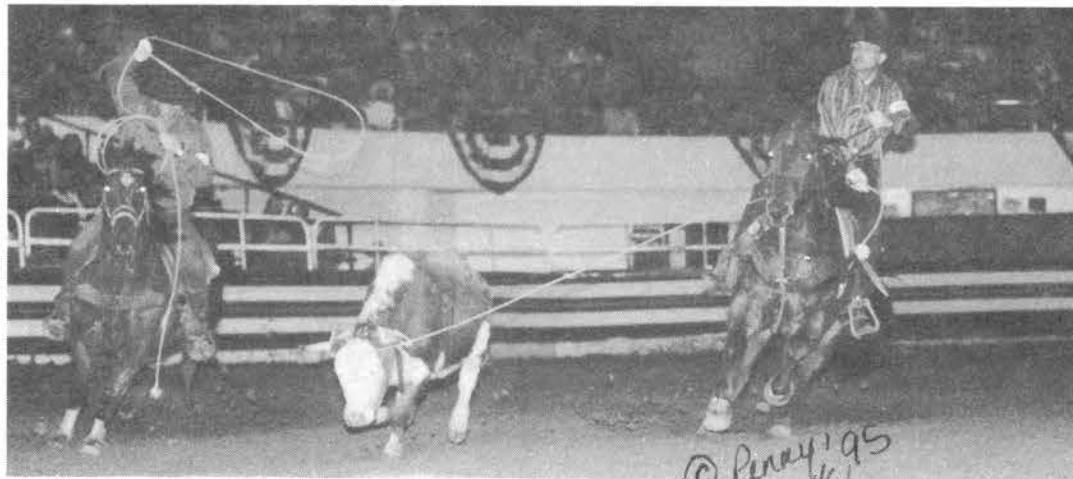

I understand that this document maybe treated as a complete defense to any legal action I might bring against the NRA for any injuries or other damages I might suffer.

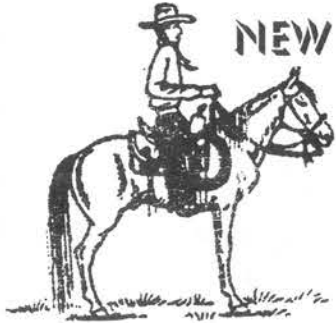

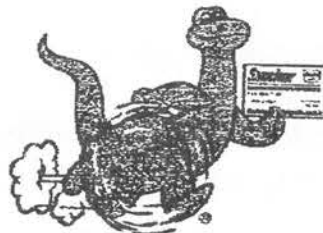

CENTRAL ENTRY POINTERS

As we begin our 11th year of service to the Northern Rodeo Association, here are some reminders to assist your entry process.

The time that you enter has no bearing as to when you will be up. It doesn't matter if you are the first entry of the day, or the very last contestant to enter, positions are drawn by computer after entries close.

Following are some things that could help getting your preference: 1. Keep your Buddy system small. Buddy systems can get large very quickly, i.e., a husband and wife buddy, he team ropes with someone who has a wife who breakaway ropes with someone who team ropes with someone else who's wife barrel races etc., etc.. It doesn't take long to get out of hand and makes it difficult to get your preference.

2. If you don't need to buddy - DON'T - Everyone in your buddy system can ask for the same preference, but specify that you don't need to buddy. Be sure to tell the Central Entry Operator this when you enter.

3. If you need to be in a Buddy Group tell us your need to buddy when you enter.

4. You can also split. This means you could be up in one event one day and other events at some other time. This works well if you plan on being at the rodeo for all perf's and slack's. By splitting you have a chance with each event to be up with your first preference.

Remember we at Central Entry have to set rodeos even. We also have to set the rodeos the way committees and contractors tell us. Keep in mind, rodeo takes the contestant, committee and contractor to be successful.

Good luck to everyone at all the rodeos, and we hope you all get your first preferences.

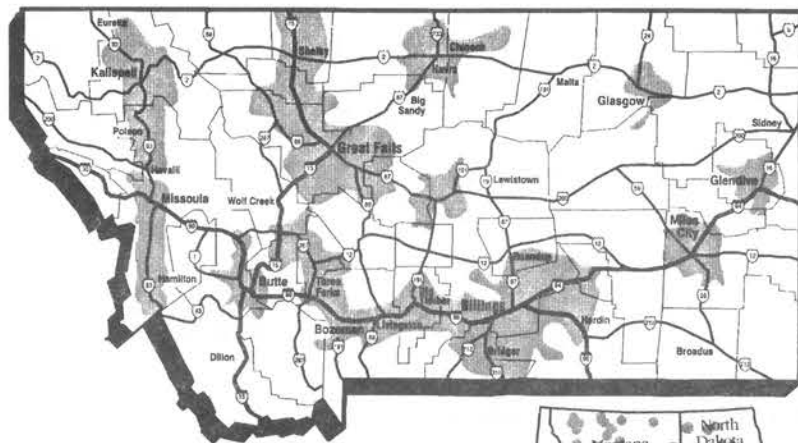

HOW TO ENTER NRA RODEOS THROUGH BIG SKY RODEO CENTRAL ENTRY DIAL 406-428-2205

Entries will be open from 10 a.m. to 6:30 p.m. every Monday. Call backs will be Tuesday from 12 noon to 6:30 p.m. unless otherwise advertised. Charge is \$3.50

Give the following information when entering a rodeo:

1. Name of rodeo
 2. Your NRA card number
 3. Your name
 4. The event or events you wish to enter
 5. Preferences you have on which performance you wish to work.
 6. Name of buddy or buddies — two per event, six total.
 7. If multi-rodeo weekend, give information for each rodeo you wish to enter.
 8. Call back Tuesday between 12 noon and 6:30 p.m. (unless otherwise advertised) to find out when you are up.
 9. Keep track of the confirmation number the operator gives you, both on entering the rodeo and calling back. Every conversation, both entries and call backs, is recorded on tape, and each person calling is given a verification number for that conversation. YOU MUST HAVE THIS VERIFICATION NUMBER IF THERE ARE ANY QUESTIONS REGARDING YOUR ENTRY OR CALL BACK.
- ANY CONTESTANT WHO DRAWS OUT OF A RODEO AFTER RECEIVING HIS FIRST PREFERENCE OF PERFORMANCES AT A GIVEN RODEO OR RODEOS WILL BE FINED \$20 PER INFRACTION.
- Late call back number is 428-2398. If you have to use the late call back number, you will be charged an additional \$2.50, so please call during regular hours.

Trade-outs and Turnouts

All NRA rodeos are trade-out rodeos unless advertised as "NO TRADE OUTS."

Trades: A contestant may trade positions/performances of competition with another contestant at anytime after entries close, provided it is before the draw for that event.

If a trade is completed before callbacks close, trades are handled through central entry and may continue to be handled up until 10 a.m. the day following callbacks.

After 10 a.m. the day after callbacks, all trades are handled through the NRA office.

Both parties involved in the trade must call the NRA office and confirm the trade.

Trades can be made at the rodeo upon consent of both parties involved before the draw in that event. Both judges and rodeo secretary must be notified of trade by both parties.

Note: a new rule passed at April 1992 board meeting states timed-event draw must be made in presence of the rodeo secretary and can be made a minimum of two hours before the performance. We bring this to your attention so contestants plan to make trades earlier.

Turnouts: As stated in the rule book, if a contestant turns out at a rodeo, the fine will be equal to the entry fees. The NRA has rules which can soften the blow of an expensive turnout.

1. Notified turnout: If you know before 3 p.m. the last working day before the first performance of a rodeo that you will not be competing at that rodeo, call the NRA office. You will be responsible for your entry fees plus a \$20 fine. The fine is \$20 (plus all entry fees) no matter how many events you are entered in. You must have your entry fees included in the payoff for that rodeo in which you will not be competing, so alternative ways to get your fees to the rodeo need to be considered.

2. If it is too late to notify, you can find someone who will pay your fees at the rodeo for you and notify the secretary, judge, and contractor that you will not be there, your fine is half your entry fee (plus your entry fee).

Contractors, judges, secretaries, spectators, announcer and fellow contestants appreciate knowing if you will not be there, thus an animal will not be drawn and this will eliminate unnecessary turnouts.

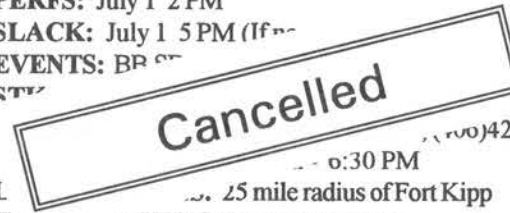

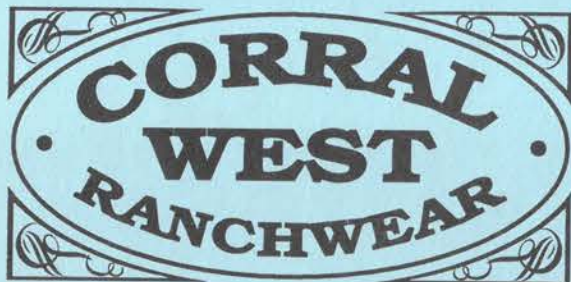
