

their Rookie Bareback Riding event for the 1992 season with 17 NRA-sanctioned rodeos to date with more coming into the office.

Rules approved for the 1992 season state that all rookie contestants must be members of the association. They must either buy a full membership for \$80 or purchase a permit for \$50 for the season.

Contestants must not have won \$500 lifetime in the bareback riding (excluding junior, high school or college rodeos.)

Once established as a rookie, the contestant will be eligible to enter the rookie bareback riding throughout the rodeo season.

Contestants must enter through the NRA official entry system, same as other NRA contestants, and pay central entry charges. Big Sky Central Entry of Lewistown takes all NRA rodeo entries and charges each contestant \$3.50 per entry.

Yearend points in the rookie bareback riding will not be included in all around standings and or Rookie of the Year Awards which are given

requirements on hauling horses across state lines Remember Rodeo Contestants: As of April 1,

many state laws have been changed. When entering another state and pulling horses, you must stop at the port of entry. (Idaho fine is \$82.50 for failing to stop).

Annual equine import permits are required when you leave Montana with your horse and plan to return.

Some states require health certificates on livestock issued in the last 30 days; No Coggins required for Idaho, however, Wyoming does require that testing.

Also know that commerical driver's license are requried if you're pulling over 18,000 gvw in Montana or 10,000 in Idaho. (A crewcab pickup with camper pulling four-horse trailer loaded is about 18,000 gvw.)

HOW TO ENTER NRA RODEOS

A. Entries will be open from 10 a.m. to 6:30 p.m. every Monday. Call backs will be Tuesday from 12 noon to 6:30 p.m. Unless otherwise advertised.

B. Give the following information when entering a rodeo:

- 1. Name of rodeo
- 2. Your NRA card number
- 3. Your Name.
- 4. The event or events you wish to enter.
- 5. Preferences you have on which performance you wish to work.
- 6. Name of buddy or buddies two per event, six total.
- 7. If multi-rodeo weekend, give information for each rodeo you wish to enter.
- 8. Call back Tuesday between 12 noon and 6:30 p.m. to find out when you are up.

C. Every conversation, both entries and call backs, are recorded on tape, and each cowboy is given verification number for that conversation.

YOU MUST HAVE THIS VERIFICATION NUMBER IF THERE ARE ANY QUESTIONS REGARDING YOUR ENTRY OR CALL BACK.

ANY CONTESTANT WHO DRAWS OUT OF A RODEO AFTER RECEIVING THEIR FIRST PERFERENCE OF PERFORMANCES AT A GIVEN RODEO OR RODEOS WILL BE FINED \$20 PER INFRACTION.

Late call back number is 428-2398. If you have to use the late call back number, it costs an additional \$2.50, so please call during regular hours.

Animals-rights group protests not new to rodeo

(Reprinted by premission from Agri-News) Not even the closed-door, public-banned steerroping contests were satisfactory to the animalrightists.

They wanted and got court arrest summons against promoters and cowboys in a rodeo at a British exhibition in London.

And with further pressure and support from Britain's home secretary in the House of Commons, even the private steer-roping sessions were shut down before the rodeo ran its course.

A current bill in the U.S. Congress that would cover exhibition animals under the Animal Welfare Act and threaten activities of rodeos. zoos, circuses and horse races reminds that animal-rightists have been at it for a long time.

Even if the measure by Rep. Peter Kostmayer, D-Pa., is not given high likelihood of passage, it is reminiscent of how long the folks with the animal agenda have tried to change accepted practices for treatment and use of animals not only in normal commercial channels but in public exhibitions.

The five court summons in London were against Tex Austin and his American entourage putting on the rodeo at the British Empire Exhibition at Wembley Stadium. They were charged with cruelty to animals in the steer-roping contest.

One of the summonses was returnable against a cowboy involved in a roping incident in which a steer broke its leg.

Agents of the Royal Society for the Prevention of Cruelty to Animals urged a British magistrate to try the case immediately so the rodeo might be stopped but a hearing date was set for three days before the contest was to end.

The society's agents later said they were satisfied since they mainly were concerned with preventing the rodeo from becoming an annual event in England.

The day of the summonses, cowgirl Anita Studernick was thrown from a bronco and broke her collarbone, and one steer was shot after its horn was torn off in the meshed fencing around the area.

And then promoters closed off the contested

roping competition from the public, continuing them behind locked doors with only London policemen as spectators.

"About 100,000 persons saw the other rodeo events vesterday and cheered the skill and daring of the cowboys and cowgirls," reported the New York Times. "The crowds ejected one spectator who booed last night's performance."

But three days later, after a House of Commons speech by Britain's home secretary, exhibition officials said no further steer roping would take place. Even rodeo promoters already had decided to suspend the contests pending the hearing on their summonses.

Then came rumors that the arrests would affect the annual Calgary Stampede just getting underway.

The event was under the patronage of Britain's Prince of Wales, who owned a ranch in Alberta, and its previous-year winner of the prince's prized bucking-horse-competition trophy was in London riding with the American cowboys picking up the arrest summons.

According to one Times feature: "Information just received in New York discloses that partly because of the objection in London to certain features of the rodeo there, nothing that might be considered as brutal will be permitted this year at Calgary."

Yet, during the stampede or in the days immediately following, the Times was silent on whether the London problems effected any changes at Calgary that year. Steer roping is still a part of the stampede's annual agenda.

And back in London, once the exhibition had ended, court summonses against Austin and the others simply were dismissed.

About one inch under the Times story disclosing their disposition was a Chicago & North Western Railway ad offering a pamphlet listing "Wyoming Wild West Ranches" and suggest-

"For those who enjoy horseback riding, mountain climbing, fishing for trout in mountain lakes and streams, hunting and the rugged life of the Big Out of Doors, nothing beats a vacation spent of a Wild West Ranch."

Incidently, that all happened in 1924.

"They are the ones who own it," he often said. The Carpenters started putting on winter series rodeos in the winter of 1982-1983.

The winter rodeos were the only series of its kind in the state. These rodeos were designed to help novice cowboys gain experience and the veterans could stay in shape throughout the competitive edge.

Many changes have taken place during the past 10 years of winter rodeos at the Carpenter Arena in Kalispell.

In 1986, RMR sold their stock and established contracts to a new contractor, Powder River Rodeo Company - Hank Franzen and Steve Morris.

Within one year however, RMR was back in production putting on another winter series, drawing up new contracts and buying new stock.

In the beginning, Richard, Bo, Kenny and Jeanne competed in these winter rodeos.

Today, the offspring have shifted priorities and are involved in the production of the RMR rodeos. Each of them have money and time invested in the family-owned corporation.

Jill will continue as the mainstay of the family corporation. She'll continue to secretary the RMR rodeos and sign the checks for winning cowboys.

Richard, the oldest, still ropes in NRA and PRCA rodeos throughout the region. However,

stock. At the rodeos, the oldest son can be found flanking stock, picking up, loading chutes, helping run the rodeo.

Bo is instrumental in overall rodeo production from start to finish. He drives truck, gathers, sorts, flanks. He's the main stay of the group and even before John's death, Bo was making major decisions. When John was unavailable, Bo was next in line to answer the questions about the rodeo company.

Jeanne spends much time publishing the Cowboy Digest. However, she the Friday girl on the rodeo trail. She does bookkeeping, time keeping and score tallying. She'll even grab a mike and fill in as rodeo announcer when and where needed.

Kenny, now of Kaycee, Wyo., works as Harry Vold's pickupman. He, too, contributes to the family business by selling the outstanding bucking stock to professional contractors.

RMR has sold top stock. Bareback horse, winter and come into the summer season with a "Hermie's Worm" was NRA bareback horse of the year twice, and has been to the NFR since Harry Vold purchased the horse.

The Carpenters feel they are unique in the stock contracting business because they occasionally sell off some of their top stock to allow them to buck to their fullest potential. They try to build and improve their operation by starting young horses keeping their rodeo company young and fresh.

The Carpenters work as a family to produce a professionally run rodeo that will entertain the crowd.

"The audience is 90 percent of the rodeo," John said.

"Without them we are nothing," he knew. "We try to please them the best we can. It's family entertainment."

It's family business, also. And the Carpenter family's involvement in NRA rodeo will continue in the Summer of 1992.

Surely John will nod with approval on his family who'll continue to entertain the rodeo audiences with a professionally-produced, family-run rodeos, in both summer and winter.
