CONTRACT AND AGREEMENT

- The parties desiring to better the sport of rodeo and enhance it as a sport, agree to recognize and accept as bona fide, current membership cards for any member of the Northern Rodeo Association (NRA) and the Northern Women's Rodeo Association (NWRA) entitling such members to enter any and all events under the Associations' sanction subject only to those restrictions imposed by the Associations.
- Judges, contract acts, stock contractors-producers, and secretaries involved in the production of the rodeo must be members of the NRA or NWRA.
- All rules governing contest events, rodeo entry, etc., will be those of the NRA and NWRA. Members of the Associations will adhere to and will be bound by the rules of the sanctioning Associations.
- The NRA and NWRA will enforce their own suspended lists at all rodeos under their sanction. Any person appearing on the Associations' suspended lists will make proper restitution to the Associations or his/her entry will not be accepted.
- It is agreed that notification of all rodeo approvals by the NRA and NWRA (dates, added money, entry fees, times of opening and closing of books, etc.) will be mailed to the NRA/NWRA office at least 30 days prior to the opening performance of said rodeo.
- In consideration of the items listed above, the NRA/NWRA shall list, advertise, promote and publish rodeo results on NRA/NWRA website of all said rodeos. The NRA/NWRA may also require that any of the Associations' sponsors be promoted as part of the rodeo production.
- The applicant does hereby submit this application for approval to conduct an NRA/NWRA sanctioned rodeo. When granted approval the applicant does hereby agree that the rodeo is approved as submitted and that the applicant will hereby conduct the rodeo in accordance with the rules of the NRA/NWRA as they now exist or as they are amended by the NRA Board of Directors and NWRA Board of Directors.
- This application expressly provides for co-sanction by the NRA and NWRA.
