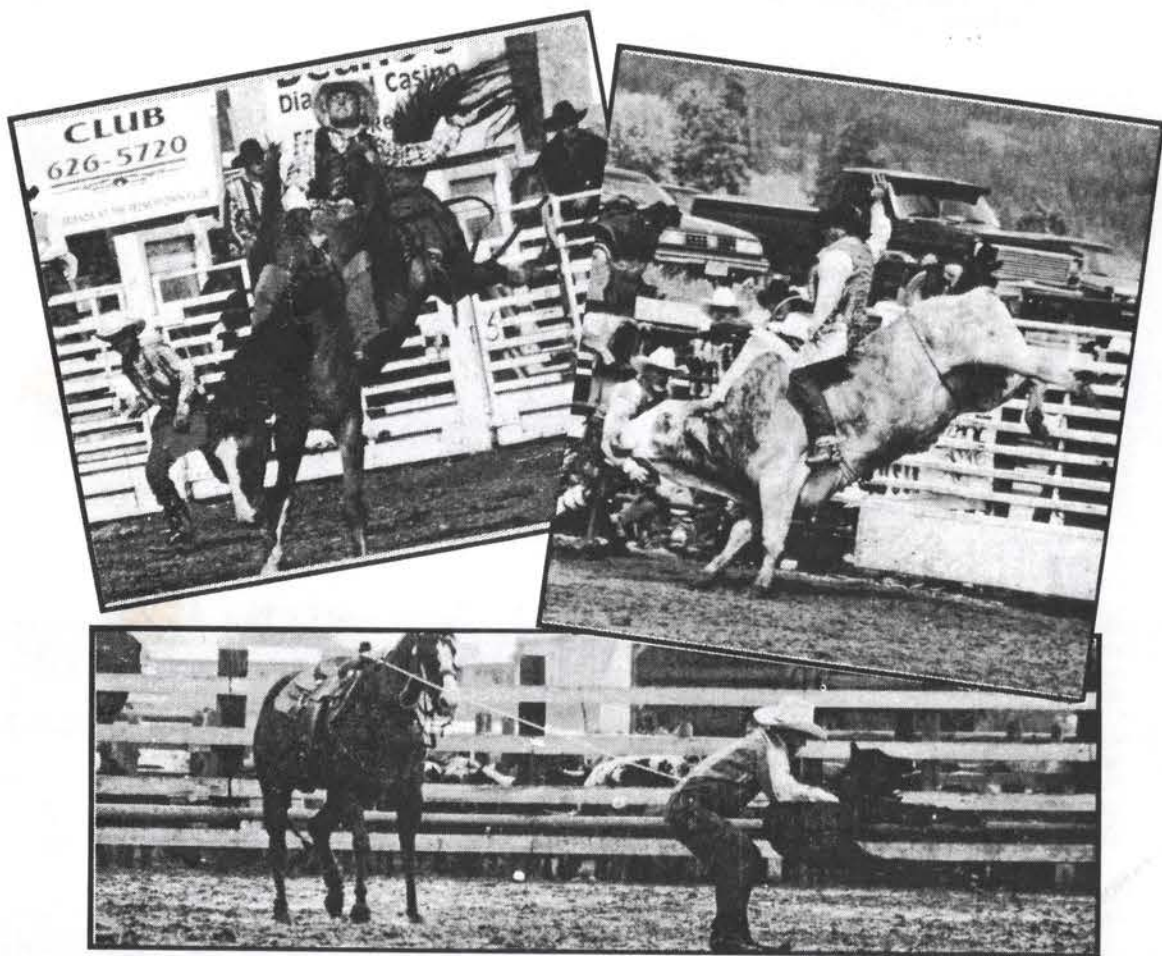

Don't miss this one! Important new change for the 1998 season does affect you!

Rule M.1.10.1. All individuals must purchase their card through the NRA office before they can enter a rodeo. The application must be signed, witnessed or notarized and have correct amount of money submitted or it will be refused. *The application must reach the NRA office 5 (five) days before entries are taken.*

And, if you or someone you know was placed on the NRA's ineligible list for a turn-out prior to 1992, you have now been granted amnesty! Come on back! The Board voted at their fall meeting to clear all fines (except NSF checks) prior to 1992.

Helpful Tip:

Slack may be used as a first preference when entering an NRA rodeo, however, **performances must be filled before any slack preference is recognized. All slacks are if necessary.**

Where are they Now?

This is the second in a series of past champions (call them heros or legends if you want). A touch of some of the past success and history of rodeo sometimes gets forgotten in today's rodeo world. In many cases, the people who competed in the past set the pace for what rodeo is today. Merle Boyce is one of those special men.

Five event rodeo cowboy got rodeo bug early

Merle Boyce (now 67) entered his first rodeo in Warick, Montana at a very young age, and he must have been bitten big by the rodeo bug.

In his rodeo career he competed all over Montana, at the Calgary Stampede, and even back east into Indiana and Wisconsin.

An authentic all-around hand, this Winifred cowboy's favorite event was the saddle bronc riding although he also competed in calf roping, steer wrestling, bareback riding, and team roping.

Merle and his wife Margie raised three boys, ran their ranch, and set their boys and their families to farming.

"I thought we raised cowboys, and they turned into farmers," says Boyce.

Their sons and families: Cleo and Mary Dee, Danny and Laura, and Gary (and Gary's wife-to-be, Marietta) all ranch, farm or teach school near the same ranch that Merle and Margie moved to when they were married May 18 forty years ago.

When their sons were old enough to sit in the saddle and swing a rope, they helped establish NRA family rodeo. The Boyce family was very competitive and successful.

Some of Merle's championship titles include: 1963 NCMRA Saddle Bronc Riding, 1966 All-Around and the Saddle Bronc Riding, 1969 and 1971 NRA Steer Wrestling.

In the 1960's Merle and fellow contestant Connie Cox traveled to Indiana and Merle won two saddles: one for winning the saddle bronc and

one for winning the all-around.

"Rodeo has changed. We used to stay all night at each rodeo", says Boyce. "It seems to be faster now, or else we're just getting slower!"

Merle and Margie had a good steer wrestling team, Little Joe and Stormy, both bay geldings. Stormy, the hazing horse, was also Margie's barrel horse.

"We did everything on him: bull-dogged, barrel raced, hazed and team roped," says Boyce.

"We quit rodeoing because we bought a dog-gone farm and went to work," says Boyce.

"We have six grandkids and to get them all horseback is a job in itself!"

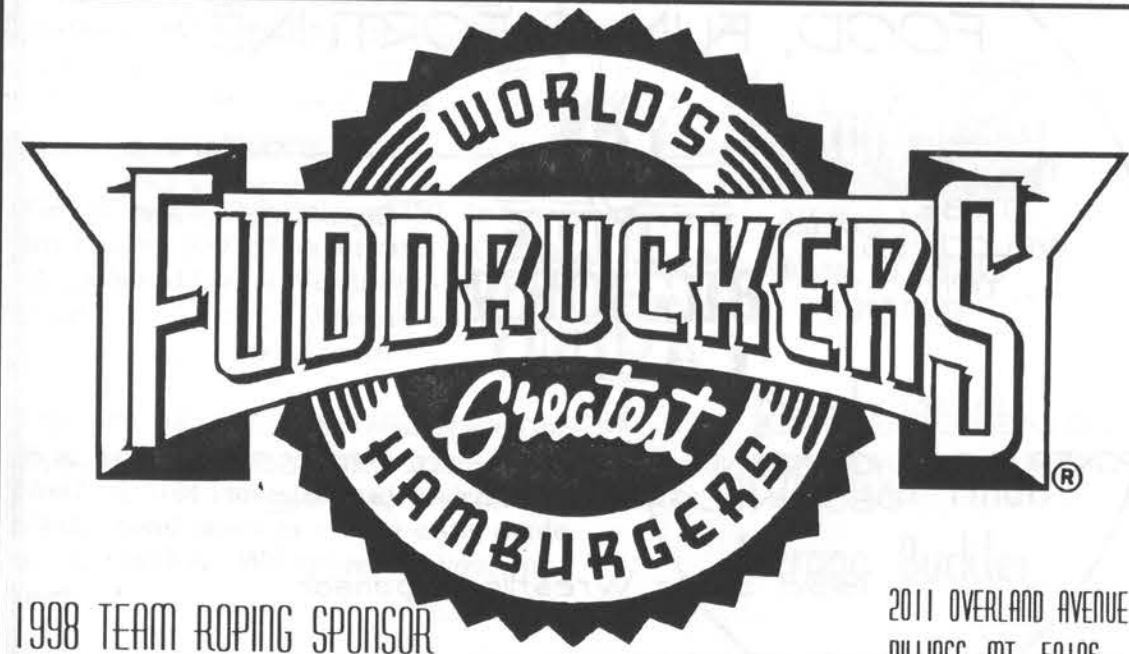

\$7,000.

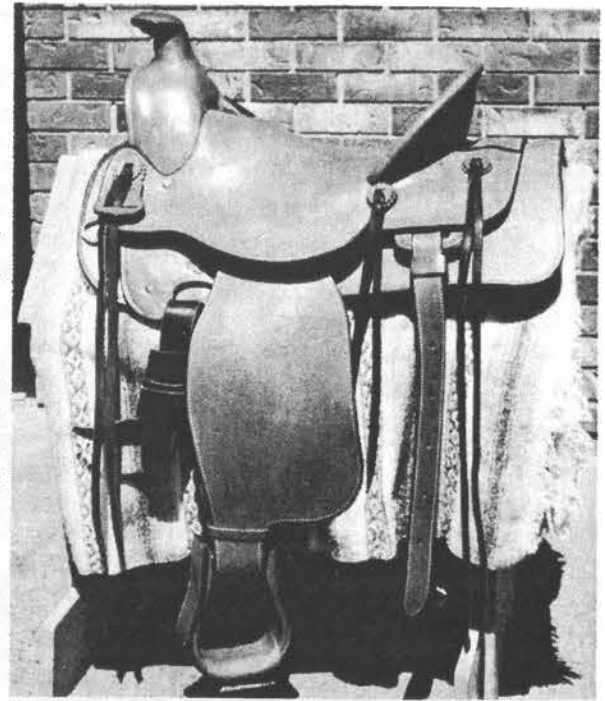

I understand that this document may be treated as a complete defense to any legal action I might bring against the NRA for any injuries or other damages I might suffer.

Drawouts, Tradeouts and Turnouts

The NRA Guidelines: for complete information, please refer to the NRA rulebook section A.8.0. The following is provided for your convenience.

Drawouts: At the time of call back, a contestant may draw out of a rodeo(s). There is not a charge IF you did not receive your preference of performances. However, rule A.4.1.4 states: "Any contestant who draws out of a rodeo after receiving their first preference of performance at a given rodeo or rodeos will be fined \$20 per infraction."

Tradeouts: All NRA rodeos are trade-out rodeos unless advertised in the rodeo listing as "No Tradeouts".

A contestants may trade positions/performances of competition with another contestant at anytime after entries close, provided it is before the stock draw for that event.

If a trade is completed before callbacks close, trades are handled through centray entry and may continue to be handled up until 10 a.m. the day following callbacks.

After 10 a.m. the day after callbacks, all trades are handled through the NRA Office 406-252-1122. Both parties involved in a trade must call the NRA office and confirm the trade.

Trades can be made at the rodeo upon consent of both parties involved before the draw in that event. Both judges and rodeo secretary must be notified of trade by both parties. NOTE: The timed-event draw must be made in the presence of the rodeo secretary and can be made a minimum of two hours before the performance. We bring this to your attention so contestants plan to make trades earlier.

Turnouts: As stated in the rulebook, if a contestant turns out at a rodeo, the fine will be equal to the entry fees. The NRA has rules which can soften the blow of an expensive turnout:

1. Notified turnout: If you know before 3 p.m. the last working day before the first performance of a ro-

deo that you will not be competing at this rodeo, call the NRA Office. You will be responsible for your entry fees plus a \$20 fine. The fine is \$20 (plus all entry fees) no matter how many events you are entered in.

2. If it is too late to notify the NRA Office, you can find someone who will pay your fees at the rodeo for you and notify the secretary, judges, and contractor that you will not be there, your fine is half your entry fee (plus the payment of your fees at the rodeo).

Courtesy, please. Contractors, judges, secretaries, spectators, announcers, and fellow contestants appreciate knowing if you will not be there, thus an animal will not be drawn and this eliminate unnecessary turnouts.

Medical and Vet Releases: As soon as you are aware that you will be unable to compete at an NRA rodeo you have entered due to a medical or vet release, contact the NRA office. With a medical or vet release you are not responsible for your fees but releases must be sent into the NRA office within five days after the rodeo along with a \$10 processing fee per rodeo.

Vet releases are accepted in the barrel racing event only. Keep in mind, when you medical or vet release, there is a five day waiting period before you can participate in another NRA rodeo.

Always remember, if you have questions, feel free to contact the NRA Office at 406-252-1122. We will be glad to assist you. Wishing you a great season!

How to enter NRA Rodeos

Welcome to the Northern Rodeo Association. NRA rodeos have utilized Big Sky Rodeo Central Entry since 1984 and offer the following guidelines to assist you. Take a moment to familiarize yourself with the NRA's rules on Central Entry. They can be found in section A.4.0 in the rulebook. A thorough knowledge of the NRA rules which apply to entering will help you better achieve your entry objective.

NRA Rodeo entry procedure through Big Sky Rodeo Central Entry • 406-428-2205

UNLESS OTHERWISE ADVERTISED, rodeo entries will open at 10 a.m. and remain open through 6:30 p.m. every Monday preceding a rodeo weekend. Call backs open at 12 Noon and remain open through 6:30 p.m. every Tuesday. Per rodeo charge of \$3.50 per contestant. Please read your rodeo listings carefully as the entry dates that fall on days other than the Monday before the rodeo will be in bold lettering.

When entering, be prepared with the following information for the central entry operator:

1. Name of rodeo(s) you wish to enter
2. Your NRA card number
3. Your name
4. The event (s) you wish to enter
5. Preferences you have on which performances you wish to work.
6. Name of buddy or buddies - NRA rules allow for two per event, six total. (To buddy together you must enter together.)
7. If a multi-rodeo weekend, give information for each rodeo you wish to enter.
8. Call back Tuesday between 12 Noon and 6:30 p.m. (unless otherwise advertised)

to find out when you are up.

9. Keep a record of the confirmation number the central entry operator gives you, both upon entering the rodeo, and when you call back. Every conversation, both entry and call back, is recorded on tape, and each person calling is given a verification number for that conversation.

In the event of a discrepancy, you **MUST** have your confirmation number available. No complaints against Central Entry will be considered valid unless a confirmation number is given.

If you do not call back during the specified call back times, late call backs will be accepted at the late call back number 406-428-2398. There is an additional charge of \$2.50 per rodeo for this service.
