# CHATting WITH CHUCK ABOUT SPORTS MEDICINE...

## Immediate care of sprains, strains, and contusions

A sprain is an injury to the tissue that supports a joint, generally the ligaments and the capsule. They commonly occur when an excessive load or force is applied to the joint. Examples are ankle, knee, wrist, and elbow sprains. A strain is an injury to a muscle and/or its tendons. They can occur as a result of overuse and/or overload. Examples are the hamstrings, extensors of the spine, biceps, and the flexors of the wrist. Contusions or bruises result from direct blows to the soft tissues - skin, muscle, tendon, nerve, connective tissue - or to bone. Examples are contusions to the chest, thigh, hand, or knee.

Rodeo injuries range from the very mild to very severe. When you get hurt, it is often difficult to know the seriousness of the injury; therefore, how it needs to be managed. For the last 30 years, my work has been with the physical health of the young active athlete. The following principles have served me very well.

1. If, in those first moments following injury, you feel lightheaded, nauseated, weak, are pale and experiencing real pain you might well have a significant injury. If anything - pain, swelling, sensation, deformity, appearance, loss of function - seems dramatically abnormal get

advice from a competent health care provider.

2. The discomfort, swelling, and loss of function that accompany mild to moderate injuries will usually peak within 24-48 hours. As healing occurs, improvement should be noticed on a daily basis. If the injury does not improve, get advice.

3. Compression or pressure provided by an elastic wrap, elastic sleeve, etc., is important. It should feel snug, but not so tight as to cause aching, tingling, numbness, or skin color changes distal to the compression.

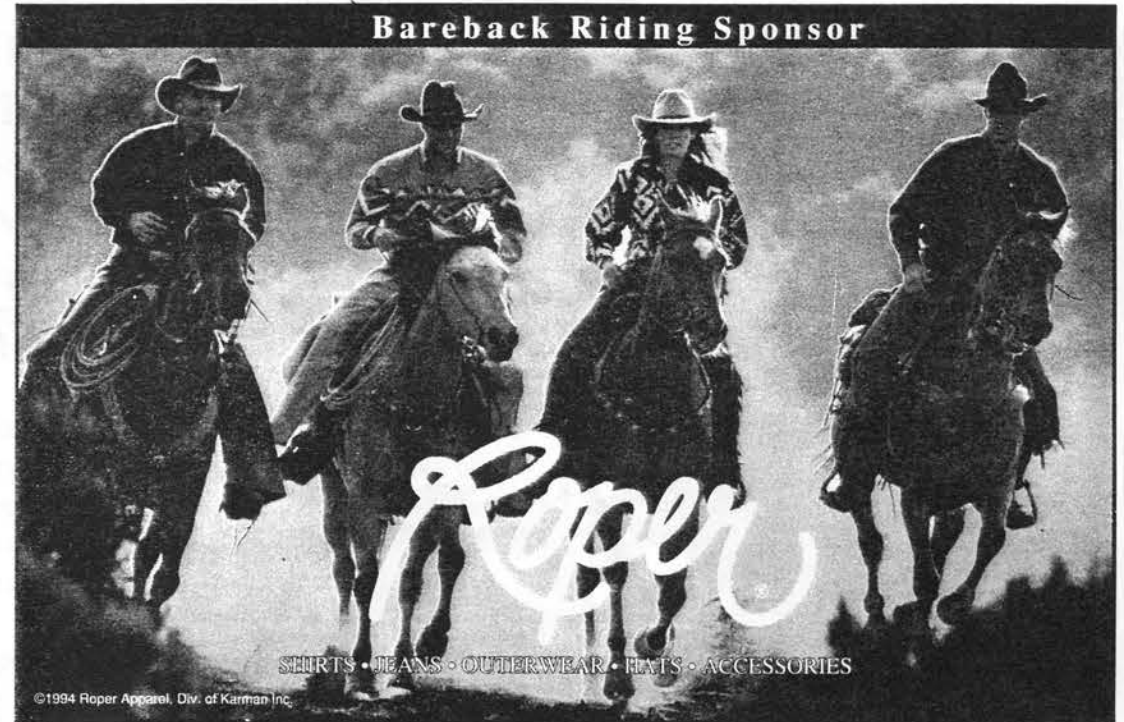
4. Ice or cold will help control the symptoms of most injuries. Depending on the size of the body part, 7-20 minute application periods repeated every 2-4 hours is a reasonable guideline. Cool the site - do not freeze the site; over icing can damage the skin and underlying nerves.

5. Elevate the injured part above the level of the heart if this is reasonably possible.

6. Placing the injured part at relative rest will help the body stabilize the injury site and initiate healing. Relative rest means rest from those functions that bother the injury; but, not necessarily from those that do not aggravate the injury.

7. Most injuries will feel better when supported especially during the period of relative rest and as you begin to reuse it as healing progresses. Sling, braces, splints, wraps, binders, neoprene supports, and crutches are possible aids.

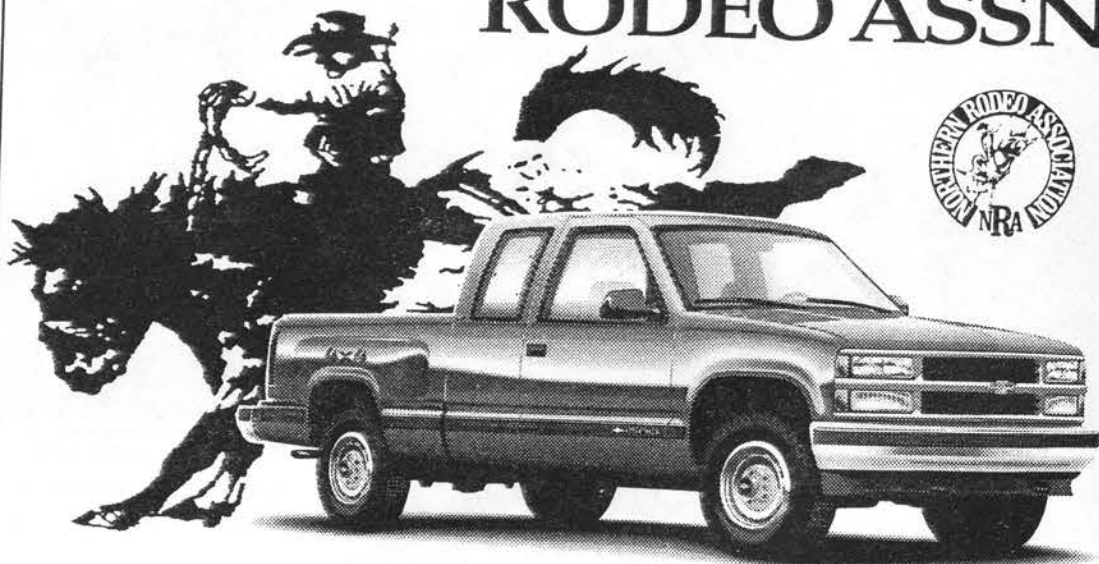

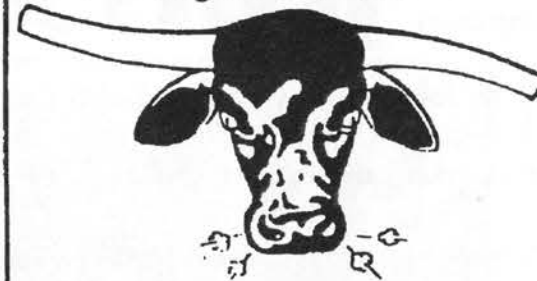

## Belgrade Youngster Wins World Title

The Josey World Champion Barrel Race at Marshall, Texas, bills itself as the highest-paying youth barrel race in the nation.

Belgrade cowboy Colt Tew has no reason to doubt its claim after winning the youth and overall world championships there May 3-5.

Tew, an 11-year-old home-school student, was the only competitor out of 289 to break the 15-second barrier. After not placing in the first-go, he went on to win the second-go, third-go, short-go and average in the 13-and-under youth class, his times were also good enough to win the overall.

The Josey World Champion Barrel Race is open to all competitors under age 20. Competitors do not have to qualify, but do have to pay an entry fee. This year's event drew barrel racers from 24 states and Canada.

For Tew's efforts he won a Four Star aluminum two-horse trailer, complete with a dressing room in the front, a saddle, a belt buckle, a trophy, clothes, etc. He also gleaned a silver hackamore for having the fastest time out of 720 runs made at the three-day event.

"I was surprised," Tew said. "It was just pretty much amazing to win it."

Colt is the oldest child of Clay and Roxie Tew and has been competing in rodeos for six years. In fact all the Tews who are old enough, including Clay and Roxie, participate in rodeos.

"It's kind of a family sport for us," Roxie said.

Helping Colt to the world title was his horse Feathers, a nine-year-old quarter horse mare that he's been riding for four years.

"She does pretty good," said Colt of Feathers.

But Colt isn't ready to rest on his barrels at such an early age. He's planning to keep busy this summer.

"Oh yeah, we go to a lot of rodeos in the summer," Colt said.

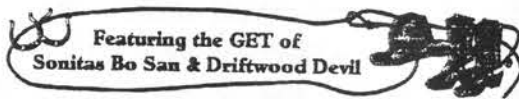

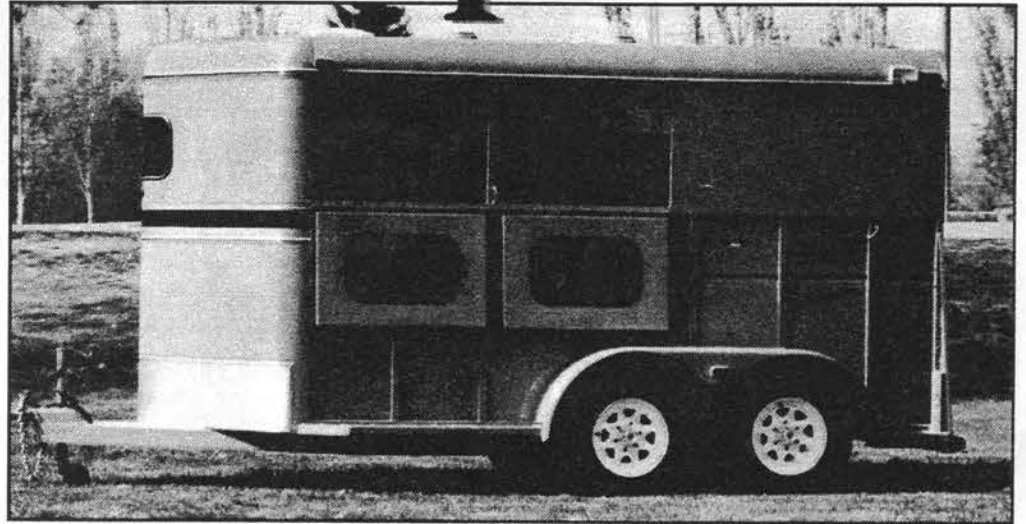

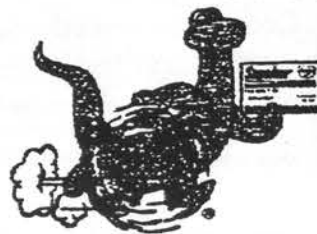

The CommNet Cellular offer is still available to all NRA members. If you have any questions please call the NRA Office.

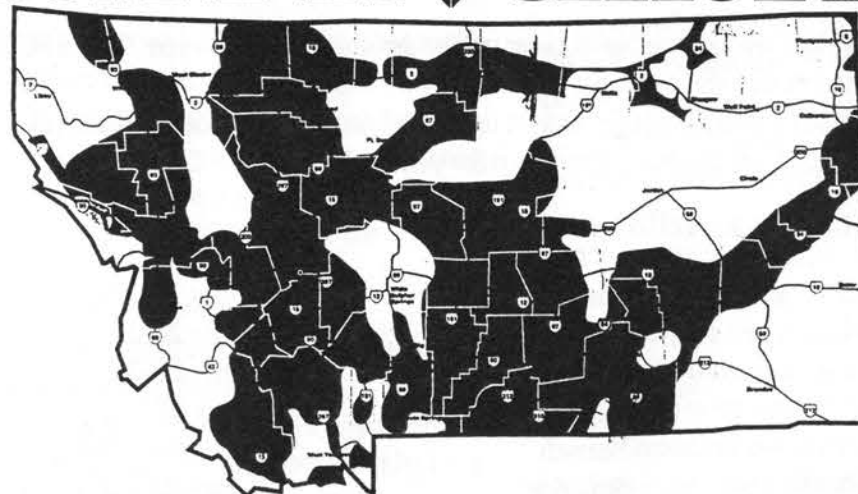

## Central Entry Pointers

By Sharon Martin

As we begin our 12th year of service to the Northern Rodeo Association, here are some reminders to assist your entry process.

The time that you enter has no bearing as to when you will be up. It doesn't matter if you are the first entry of the day, or the very last contestant to enter, positions are drawn by computer after entries close.

Following are some things that could help you get your preference:

1. Keep your buddy system small. Buddy systems can get large very quickly, i.e. a husband and wife buddy, he team ropes with someone who has a wife who breakaway ropes with someone who teamropes with someone who teamropes with someone else who's wife barrel races etc.. It doesn't take long to get out of hand and makes it difficult to get your

preference.

2. If you don't need to buddy - DON'T - Everyone in your buddy system can ask for the same preference, but specify that you don't need to buddy. Be sure to tell the Central Entry Operator this when you enter.

3. If you need to be in a buddy group tell us your need to buddy when you enter.

4. You can also split. This means you could be up in one event one day and other events some other time. This works well if you plan on being at the rodeo for all perf's and slack's. By splitting you have a chance with each event to be up with your first preference.

Remember we at Central Entry have to set rodeos even. We also have to set the rodeos the way the committees and the contractors tell us. Keep in mind, rodeo takes the contestant, committee and contractor to be successful.

Good luck to everyone at all the rodeos, and we hope you all get your first preferences.

Don’t let it fade into, a thing of the past.



## 1996 Northern Rodeo Association RULECHANGES Supplement to current rulebook:

Clarification on Bull Riding Day Money ruling: It was moved and seconded: add to rule A6.5.1: If a contestant turns out of a performance and pays his fees AFTER the day money for his performance has been paid out, day money to be included in overall payoff for the rodeo. PASSED.

Clarification on conflicting rules R.9.1.1 and R.9.1.6. It was moved and seconded: R.9.1.6 was to be replaced by R.9.1.1.

Clarification on “extra” animal drawn in the timed events. Some judges “issue” the “extra” from the first draw to the first contestant in the next draw. Proper procedure is not to “issue” animal, but put animal back in draw and redraw.

Problems with rodeo arenas using overhead pull barriers were discussed. Committees are strongly encouraged to replace the overhead pull barriers with side pull barriers. Item to be included on committee suggestion listing.

Clause in the Central Entry contract allowing contestants to work all NRA sanctioned rodeos in a given weekend or time period be evaluated with discussion at the February meeting. It was moved and seconded: The guarantee of contestants being able to work all NRA rodeos in a given weekend or time period be removed from the Big Sky Rodeo Central Entry contract.

Discussion concerning Logan Coach Judging Program. It was moved and seconded to accept the NRA Judging Program rule additions at the General Membership meeting. It was moved and seconded that judges must attend one mandatory judges seminar /conference. NRA JUDGING PROGRAM RULE ADDITIONS AS PASSED BY THE BOARD OF DIRECTORS ARE AS FOLLOWS:

1. A judging committee will be formed with three people on it. One off the board of directors, one rough stock person, and one timed event person. They should not be active judges. This committee will select the judges for each rodeo and handle any discrepancies that occur. They will also rate the judges from one to five in accordance to their ability. At the end of the year, the committee will give each judge a report. This will let him know his strong and weak points, enabling the judge to better himself.
2. Contestants will pay an additional \$1 in their entry fee to the judges. This will help cover the judges expenses for coming and maybe make a little money. This will also bring back some of our more experienced judges.
3. In rodeos that have big slacks, there will be a third judge assigned to do the slack draw. The third judge will be paid from the Logan Coach funds.
4. All beginner judges will do the draw and set up the barriers at the rodeos with the experienced judge overseeing.

PASSED/UNANIMOUS.

Judging Committee was formed in accordance with new additions. Dick Lyman as chairman, Mark Salmond representing timed event contestants, and Steve Cutler representing rough stock contestants.

Page 24 (Rodeo approval and administration) Add to the last sentence of A.2.20: Certified timer defined as a timer who is experienced and has attended an NRA timers clinic/seminar. Individuals who have attended a timers clinic/seminar, but who are not experienced, are required to time a rodeo with two experienced timers in order to gain full certification.

Page 25 (Rodeo approval and administration) A.3.12 Two or more timers will use hand-held digital watches and record the average of two times at all rodeos, ignoring any digits beyond the tenths.

Add to that section: A.3.14. If both timers miss the start or stop of the run (timed events) or if both watches malfunction, the contestant receives a re-run. This is a factor that is taken for granted but is not in the rulebook.

Page 30 (Central Entry, Secretary, and Rodeo Office) Add new paragraph: A.5.25: Management shall make every effort to provide a weatherproof building or enclosure suitable for use as a rodeo office (excluding the announcer's stand). This facility should be provided with electricity, and where possible, telephone.

Page 73 (Electric Eye Timer) Add the following underlined words to the last two sentences: "Timers will record the times that appear on the electric-eye controlled readout disregarding the thousandth and recording the times in hundredths. Timers will also record the average time from the hand-held stopwatches, in hundredths, in the place so designated on the timers sheet."

Page 15 (Membership)M.2.4. Non contesting membership: This section should be re-worded so there are two different categories of non-contestant membership for timers and secretaries. I think this could be accomplished simply by adding another box on the membership application, since the membership fee is different for both. My rationale in suggesting this is so that when selection of timers at the NRA Finals comes around, the voters would select from a list of timers. ALL ABOVE RULES PASSED BY GENERAL MEMBERSHIP. Discussion. PASSED\*\*\*\*\*

It was moved and seconded: All bucking stock that is brought to the NRA Finals rodeo must be owned by an NRA Stock Contractor. Any livestock nominated, brought, and competed on at the NRF without proof of ownership will not receive payment.

It was moved and seconded: Per animal increase of \$50 in 1997, followed by an additional \$25 in 1998, and an additional \$25 in 1999. PASSED.

It was moved and seconded: A.2.12: All local entries must have their entry fees paid and a release signed before the rodeo begins.

LBR contestant order at the NRA Finals was addressed. It was moved and seconded: For the NRA Finals rodeo, the ladies barrel racers will run in the 1st through 10th position for the first go; For the second and third go-arounds, the order of the event will be the contestant's finish in prior go-arounds. There will be no trading of positions at the NRA Finals. PASSED.

It was moved and seconded: The top two (2) voted bullfighters work the NRA Finals rodeo. PASSED.

It was moved and seconded: Pay for each NRA Finals bullfighter be \$450. PASSED.

## NRA GUIDELINES FOR TRADE-OUTS AND TURNOUTS

All NRA rodeos are trade-out rodeos unless advertised as "NO TRADE OUTS."

### TRADEOUT PROCEDURE:

A contestant may trade positions and/or performances of competition with another contestant at anytime after entries close, provided it is before the draw for that event.

If a trade is completed before callbacks close, trades are handled through central entry and may continue to be handled by central entry up until 10 a.m. the day following callbacks.

After 10 a.m. the day after callbacks, all trades are handled through the NRA office at 406-252-1122.

Both parties involved in the trade must call the NRA office and confirm the trade. **NO EXCEPTIONS.**

Trades can be made at the rodeo upon consent of both parties involved before the draw in that event. Both judges and rodeo secretary must be notified of the trade by both parties.

Keep in mind, the timed event draw must be made in the presence of the rodeo secretary and CAN be made a minimum of two hours before the performance. This is brought to your attention so contestants can plan to make position trades earlier.

### TURNOUT PROCEDURE:

As stated in the rulebook, if a contestant turns out at a rodeo, the fine will be equal

to the entry fees. The NRA has rules which can soften the blow of an expensive turnout.

1. Notified Turnout: If you know before 3 p.m. the last working day before the first performance of a rodeo that you will not be competing at that rodeo, call the NRA office. You will be responsible for your entry fees plus a \$20 fine. The fine is \$20 (plus all entry fees) no matter how many events you are entered in., You must have your entry fees included in the payoff for that rodeo in which you will not be competing, so alternative ways to get your fees to the rodeo need to be considered. The NRA office will be glad to help you with this.

2. If it is too late to notify the NRA office, you can find someone who will pay your fees at the rodeo for you and notify the secretary, judge, and contractor that you will not be there, your fine is half your entry fee (plus your entry fee).

Contractors, judges, secretaries, spectators, announcers and fellow contestants appreciate knowing if you will not be there, thus an animal will not be drawn and this will eliminate unnecessary turnouts.

### MEDICAL AND VET RELEASES:

As soon as you know that you will be unable to compete at an NRA rodeo due to a medical release, contact the NRA office. With a medical or vet release you are not responsible for your fees but releases must be sent into the NRA office within five days after the rodeo along with a \$10 processing charge per rodeo. Vet releases are accepted in the barrel racing event only. Keep in mind, when you medical or vet release there is a five day waiting period before you can participate in another NRA rodeo.

**MEMBERSHIP:** Entitles purchaser to work all sanctioned rodeos without restrictions, to share all advantages of a member in good standing including such items as a guarantee to your entry fee; check writing privileges after the first year initiation period; and a subscription to the newsletter.

**PERMITS:** Entitles purchaser to work all sanctioned rodeos accepting permits as listed in newsletter until \$500 is won. After \$500 money limit is won by permit holder, a card must be purchased, the price of card to be the dollar difference between the cost of a permit and the cost of the card. Permit holder's points will be credited to the year-end standing, however, the contestant must be a card holder to compete at the NRA Finals. The \$500 money limit will be accumulated from year to year, allowing the contestant to purchase a permit each year until the \$500 is won. A card holder the previous year cannot purchase a permit the following year.

A CONTESTANT COMPETING IN BOTH ADULT AND JUNIOR EVENTS MUST HOLD BOTH A  
JUNIOR AND ADULT MEMBERSHIP

# RELEASE AND AGREEMENT NOT TO SUE

I realize conditions of the rodeo arena change from time to time and may become more hazardous, that rodeo animals are dangerous and unpredictable and there is INHERENT DANGER in rodeo which I appreciate and voluntarily assume because I choose to participate in such events. I make this choice even though I have observed or participated in events of this kind in the past and know conditions, facilities, rodeo animals, and other rodeo contestants and participants pose a danger to me. I recognize and expressly agree to assume the entire risk of any and all accidents or personal injury including serious paralysis or death which I might suffer during my participation in said events.

I further COVENANT AND AGREE NOT TO SUE THE NRA for any injury, damages or death which occur as a result of my participation in said events and any claim or damage therefore. I understand that this document maybe treated as a complete defense to any legal action I might bring against the NRA for any injuries or other damages I might suffer.

I understand and agree this RELEASE AND AGREEMENT NOT TO SUE extends to any and all claims I may have, specially including but not limited to, claims arising out of participation in said events, claims with respect to the design, manufacture, repair, or maintenance of the facilities or equipment which I will be using, or with respect to the conditions, qualification, instructions, rules or procedures under which my use of said facilities or equipment are conducted or from any other cause.

I UNDERSTAND AND AGREE THIS RELEASE AND AGREEMENT NOT TO SUE extends to ACCIDENT, INJURY, OR DEATH OCCURRING DURING THE TERM OF MY MEMBERSHIP IN THE NRA. Any subsequent Releases and agreement I might sign in the future shall amplify, but shall in no way limit, the provisions of this document.

I further state and certify that I have carefully read the foregoing Release, know the contents thereof and sign this Release and Agreement Not to Sue as a free and voluntary act. I am not relying on any statements of representations of any party released hereby. I UNDERSTAND THIS IS A RELEASE OF ALL CLAIMS.

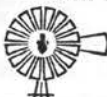

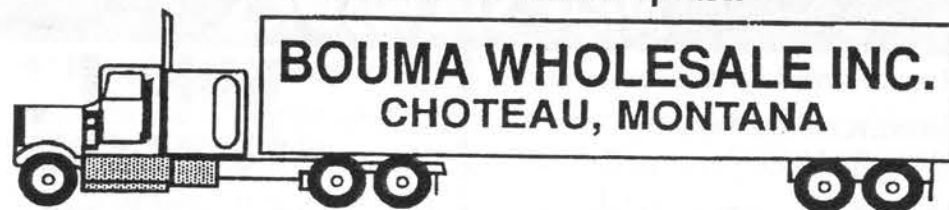

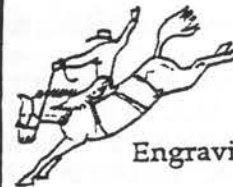
